Information Ethics, Law, and Policy, MSIM/IMT 550: SU25 (online), WI25 (2 sections), AU24, SU24, SP24 (online sections), WI24 (2 sections), WI23 (3 sections), WI22 (2 sections), SU21 (online section), WI21 (2 sections), WI20 (2 sections), INFO 450/350/311: SU25, WI25, WI24, WI23, AU21, SP05–SP2018, PHIL 401: SU05, SU11, LIS 550 SP15, LIS 550 online section SP09, AU15, AU16, SP18. This class is designed to provide students with a framework for analyzing the ethical, legal, economic, and socio-political issues surrounding information, information technologies, and the information industries. The class explores numerous policy and ethical issues of information access and control including: intellectual property, file sharing, free speech, privacy, the ethics of the dark web (TOR), and national security.

Technology, Freedom, and Justice, INFO 498 AU20. In this course, attention will be given to different aspects of the relationship between technology, freedom, and justice. The central question we will consider is: How has technology, specifically information technology, enhanced or undermined freedom, liberty, and justice?

Historical Foundations of Information Science, INSC 500, AU15, AU16 AU17. Along with introducing students to faculty members and research strands in the iSchool, the purpose of this seminar is to introduce new Ph.D. students to some of the readings and areas that form the historical foundations of information science. With scholars and students coming from disparate fields of study it is important to provide a foundation and common language for ongoing studies in information science.

Philosophical and Theoretical Foundations of Information Science, WI24. PhD student seminar. This course is an in-depth exploration of the philosophical, theoretical, methodological, and historical foundations of social science, information science, and the study of information.

Information Ethics and Policy, INSC 555 AU14, AU12, AU08. As a graduate seminar and reading group this class is designed to introduce PhD students to the area of information ethics. Different sections focus on different issues such as: intellectual

- property, file sharing, free speech, privacy, the ethics of the dark web (TOR), or national security.
- Contemporary Moral Problems, AU13, SP13, SP12, SP09, SP08, SP07, SP06, SP05 (UW), AU2000 (two sections) (EMU), SP99, AU98, (CSU), AU97 (WU), SP97, WI96, SP96, AU96, WI95 (OSU). This course introduced positions in normative ethical theory, moral epistemology, and metaethics while surveying issues such as euthanasia, abortion, affirmative action, animal rights, the distribution of wealth, pornography and freedom of speech, and computer ethics. As an applied course, special emphasis was given to how abstract moral theories related to concrete everyday moral problems.
- *Medical Ethics*, WI02 (EMU), SP97 (OSU). This course introduced positions in normative ethical theory while surveying issues in medical ethics. Issues that were covered included, abortion, euthanasia, socialized health care, cloning, doctor/patient confidentiality, and genetic enhancement.
- Business Ethics, WI03, AU00 (EMU), SP98 (CSCC), SP98 (OSU). This course introduced positions in normative ethical theory while surveying issues in business ethics. Issues that were covered included, affirmative action, sexual harassment in the workplace, employee monitoring v. privacy, employment at will, and the virtues/vices of capitalism.
- Ethics and Law in Cyberspace: Privacy, Property, and Power, SP99 (CSU), SP98 (MU). Along with a general introduction to ethical theory, topics discussed in this class included crime, abuse, and hacker ethics, ownership of intellectual property and computer software, privacy and encryption in a "wired" world, and network responsibility, liability, and professional codes.
- Ethical Theory, AU02 (EMU), AU98 (CSU). As an upper level class for majors only this course provided an in depth analysis of the fundamental concepts and problems in moral theory. Examination of various ethical theories included, relativism, egoism, utilitarianism, deontology, virtue ethics, intuitionism, moral skepticism, and nihilism.
- Graduate Seminar in the Philosophy of Law: Intellectual Property, Privacy Rights, Free Speech, Security, AU10, AU2007 (UW). This class started with several attempts to justify intellectual property rights and then turned to the moral and legal foundations of privacy and free speech. Undergraduate versions SU04, SU07.
- Justice Matters (Values 512): AU09, AU08. This course introduced graduate and professional students from a wide range of backgrounds to some basic moral questions about social structures and institutions. In particular, most of the discussion centered on various questions about justice construed as the basic virtue of social institutions.
- Philosophy of Law, AU04 upper level/graduate (UW), AU02, AU01, AU00 (EMU), SP99 (CSU). This course surveyed a number of issues in the philosophy of law including the nature and function of law, methods of justifying legal systems, the logic of legal

- reasoning, analysis of fundamental legal concepts, legal positivism and natural law theory, legal paternalism, constitutional privacy, free speech, and theories of punishment.
- Political and Social Philosophy, AU12, AU06, AU03 (UW), WI01 (EMU), SP99 (CSU), SP95 (OSU). This course introduced the political and social philosophy of Hobbes, Locke, Mill, Marx, Nozick, and Rawls. Special attention was given to problems concerning the justification of the state and state coercion, the controversy over the distribution of wealth, and the defense of private property.
- Philosophical Foundations of Libertarianism (PHIL 401) SU12. The central normative problem of political philosophy is this: How, if at all, can political authority be justified? A wide variety of answers have been proposed. Some have said that political authority is founded on some sort of agreement; others that it is justified by good consequences; and others, of course, have denied that it is justified at all. In exploring this question we will focus on the writings of Locke, Hayek, Nozick, and others.
- Intellectual Foundations of Informatics (INFO 300), AU07, AU06, AU04, WI04, AU03 (UW). Information as an object of study, including theories, concepts, and principles of information, information seeking, cognitive processing, knowledge representation and restructuring, and their relationships to physical and intellectual access to information. Development of information systems for storage, organization, and retrieval. Experience in the application of theories, concepts, and principles.
- Information Policy: Domestic and Global, SP05 (UW). National and international information policy: public and private sector policy in terms of privacy, access, and exploitation; technology infrastructures and policies supporting the information industries; digital convergence and the emerging mega-industries.
- *Introduction to Philosophy*, SP09, SP04 (UW), WI03, AU02, AU01, WI01 (EMU), AU99 (WSU), AU98 (CSU Fresno), SP96, SU96, WI98 (Columbus State), AU95, WI95, AU94 (OSU). This was a survey course of topics in metaphysics, epistemology, freewill and determinism, philosophy of religion, ethical theory, and political theory.
- Introduction to Logic, Online Logic at UW, ongoing summer 2007—2011, WI03, AU02 (online sections), WI02, SP01 (EMU), WI98, SP98, AU97 (CSCC). This course was an introduction to critical thinking and arguments. Topics covered included, inductive logic, categorical logic, propositional logic, language and argument reconstruction, and fallacies.
- Philosophy of Social Science, SP00 (WSU). This class introduced students to a number of philosophical problems related to the social sciences. Topics covered included, human action, behaviorism, rational choice, interpretation, functionalism, methodology, public goods and collective decisions, and moral problems associated with social science and research.
