Expected Learning Outcomes: Students will be able to prove substantial results arising from calculus, such as convergence of sequences, limits, and existence of derivatives. Furthermore, students will develop the ability to solve problems over multiple days. Students will think in a rigorous mathematical manner, and on occasion solve problems that the professor could not.

Methods of Assessment of Learning Outcomes: Continuous assessment of the progress of the course occurs through ongoing communication between the instructor and the students. Students are encouraged to ask questions during class and to seek the instructor's help outside of class when needed. Formal assessment occurs through exams, homework, computer assignments, and attendance. See descriptions below.

Calculator Policy: No calculators allowed on Quizzes or Exams; permitted on homeworks.

Exams: In certain special circumstances a makeup exam may be given after the student follows all university protocol.

Homeworks: Assigned weekly or bi-weekly
